Executive Director's Review

During 2008, we, at Transparency International Sri Lanka, continued to work towards our Vision of building a nation of integrity amidst many challenges.

We planned our activities based on an internal evaluation leading to major institutional changes. We commenced research studies in several key areas including education, local government, health and foreign employment. Details of our activities appear elsewhere in the Report. We continued with our advocacy work with a view to eradicating corruption on systemic issues.

We strengthened our relationships with several public sector institutions during the year. This resulted in the training of over 1,500 public officials building their capacity to deal with corruption and promoting good governance. We continued to work with over 100 Community Based Organisations (CBOs) in several parts of the country creating awareness on the need to eradicate corruption and enhance integrity at grass-root level. We took the initiative in forming new alliances with the private sector. Two seminars - one on Integrity in the Business Sector and the other on the Global Financial Crisis - organized by TISL were well attended and the response was most encouraging. The issues raised at these seminars are being followed up. We were fortunate in having Jermyn Brooks, TI Director of Global Private Sector Programmes to present the tools of business integrity developed by Transparency International at the first seminar. We were privileged to have Dr Peter Eigen, Founder of Transparency International as chief guest of the National Integrity Award presentation. He was also the keynote speaker at the seminar on global financial crisis.

The anti- NGO sentiment prevalent in the country unfortunately affected our work. The general tendency is to look at all non-government organizations with suspicion and mistrust. However, this attitude has made us continue our efforts with more determination and resolve. The challenging times have often united the anti corruption campaigners together against all odds. On a personal note, I wish to record that the grenade attack on me on 27 September 2008 is an example of the challenging environment in which social activists have to work in this country. I value the concern of the Directors Members, Staff, all our stakeholders and well-wishers, shown on that occasion.

The support and guidance received throughout the year from the Board of Directors in planning our work is greatly appreciated. Our membership, though small in number, is following our work closely. We intend to build up a closer relationship with them in the future.

I am grateful to our donors for their continued support which has helped us to plan and implement a series of programmes for the betterment of the country.

I thank the admirable staff for their unstinted cooperation and willingness to stand up to any challenge in these trying times to take the message of anti-corruption and integrity across the country.





Our Activities

Voice of the people

Helpline to air grievances

Initiatives taken by TISL during the year provided a platform for the voice of the people, particularly the underprivileged and the powerless.

The people voiced their concerns about the education sector, both positive and negative through the telephone helpline set up in August 2007 and continued during 2008. Aimed at creating a better education sector with integrity, the helpline was welcomed by the Ministry of Education. During a period of 14 months (August 2007-October 2008), 89 complaints were received of which 73 were selected for further action. These were forwarded to the Ministry, the Auditor-General's Department and the Commission to Investigate Bribery and Corruption. However, the authorities have been slow to react to the cases and no case had been resolved at the end of 2008.

The helpline offered us an opportunity to maintain a dialogue with the Ministry. Several meetings and workshops were held and a steering committee was formed to verify the complaints. A joint Complaints Committee was set up and even though no action was taken by Ministry officials, at least they got to know what the complainants felt about their activities and the issues involved. A database recording complaint and informant details and follow-up action was also developed.

Although the helpline service was discontinued from 1 November 2008, the response from the public promoted TISL to undertake an in-depth study on the forms and extent of corruption in education in Sri Lanka.





People's Platforms

People's Platforms bring together government officials and members of the general public under one roof to engage in a discussion about governance issues that directly affect the lives of the people, particularly the poor and the marginalized. In keeping with the decision to plan People's Platforms on selected governance issues, the TISL team of researchers identified several problems in the Badulla district through field investigations. A Pocket People's Platform (PPP) was thereafter held at Hali Ela on 8 November 2008 to discuss the role of the public officials in handling a problem relating to water contamination. The participants including representatives of community based organizations (CBOs) and the public got a chance to air their grievances and officials present responded.

Networking at grassroot level

More and more Community Based Organisations (CBOs) have realized the importance of engaging in anti-corruption dialogue at local level because corruption hinders economic and social development and lowers the impact of government's development programmes. CBOs are conscious of the need to address internal governance issues to ensure credibility and public trust.

75 community leaders attended seven awareness programmes conducted by TISL in Anuradhapura, Badulla, Kalutara, Kegalle and Kurunegala, The workshops have helped to strengthen the skills and knowledge of the CBOs to network and bring their collective voice and action to combat corruption.

Partnering Public Sector

Educating the public service

More and more public officials are showing willingness to be educated on anti-corruption measures. TISL works in close collaboration with the Ministry of Public Administration and Sri Lanka Institute of Development Administration (SLIDA) with a view to incorporating anti-corruption education into the curricula of public service institutions.

The accent during the year was on training of trainers (TOT) where selected public officials from the provinces were trained on enhancing integrity in the public service. Thirty six public officials from Kurunegala, Galle, Badulla, Matara, Hambantota. Monaragala, Batticaloa and Trincomalee attended an introductory workshop on 'Enhancing integrity in the Public Service'. A planning workshop to train officials from Divisional Secretariat divisions in the district was held in Kurunegala attended by 166 officials. The main objective was to introduce the training and capacity building programme in the public service at provincial level.


Following a three-day workshop where 22 officials from Galle and Badulla districts participated, trainers conducted ten workshops in Galle and another ten in Badulla for 800 district public officials using the training manual and toolkit prepared by TISL. Reports indicate that the trainees have taken action at their office level to minimize corruption.

Role model

The Department of Immigration & Emigration has become a role model of an efficient, corrupt-free public institution following the continuous training programmes conducted by TISL. Further to the 2007 programme, another 110 officials were trained at four one-day workshops in 2008.

The officials showed a willingness to be educated on anticorruption measures and the results were highly appreciated by top officials. Controller of Immigration & Emigration-P B Abeykoon publicly stated that there has been a complete change in the attitudes of the Department officials which has led to the public perception undergoing a radical change.

More and more government departments are showing interest in our awareness programmes.







Good governance workshops

In response to a request by the District Secretary, Badulla in Uva Province which is the second poorest province in Sri Lanka - was selected for TISL's 2008 Regional Programme. Public service officials in the District greatly benefited through seven workshops on good governance conducted by TISL. Five of these were for Grama Niladharis (village administrative officers) - four in the Sinhala medium and one in Tamil. 406 Grama Niladharis attended the workshops.

The balance two-day residential workshops were held for provincial service administrative officials including Secretaries to provincial ministries, Divisional Secretaries, Assistant Divisional Secretaries and Accountants. Positive results of these were evident when the Badulla District Secretariat and five provincial offices won awards at the annual Uva Province Inter-Departmental Productivity Competition.

Acknowledging the usefulness of the workshops, District Secretary - Badulla, Rohana Keerthi Dissanayake wrote: "The success of the Badulla District Secretariat in winning the first place in the Uva Province Inter-Departmental Productivity Competition was due to the conceptual change relating to governance brought about through the workshops conducted by TISL. Productivity Awards symbolizes efficiency and productivity as much as indicating good governance principles which help to curb corruption are practiced by the staff."

At regional level

Political leadership and policymakers at regional level have been made aware of the need to take effective measures against corruption. As a result, elected members and officials of regional administrative institutions show keenness to participate in TISL workshops on anticorruption.

One hundred and thirty six participants were made aware of measures to counter corruption at five workshops held in Uva (Passara) and North Western (Wariyapola & Chilaw) provinces.

The training focuses on enhancing commitment to address anti-corruption issues and increase the ability of local officials to take counter measures against corruption. The training has resulted in a change of attitude and outlook on the part of the officials.

Trade Unions as whistle-blowers

Trade unions are taking the initiative of playing the role of whistle blowers.

Following discussions with TISL, four trade unions in the health sector – Health Service Trade Union Alliance (HSTUA), Public Service United Nurses Union (PSUNU), Sri Lanka Public Health Inspectors Union (SLPHIU) and Confederation of Public Service Independent Trade Union (COPSITU) - identified the different types of corruption and malpractices in the sector and vowed to fight against them.

Thirty six members from these unions participated at a one-day seminar held with the support of the Friedrich Ebert Stiftung (FES). Six areas of corruption were identified at the group discussions. These related to misuse of financial resources, absenteeism & mismanagement of working time, engaging in private practice, favouritism in treating staff, bribery & nepotism in awarding tenders, and soliciting bribes from patients and clients.

Following these discussions, a research study was undertaken on 'Integrity in government hospitals in the Colombo District'.





Dialogue with Corporate Sector

Integrity in Business Sector

Corporate sector executives and professionals were exposed to the globally recognized TI Business Principles for Countering Bribery, at a Business Leaders Forum on 'Building Integrity and Transparency in Business Relationships'. They showed keen interest in the presentation by Jermyn Brooks, TI Director of Global Private Sector Programmes.

It was a pioneering effort by TISL to involve the private sector in exploring avenues to discuss issues on corporate governance. The need for a strategic collective action with the participation of Chambers of Commerce, Sector associations of business and professional organizations was voiced at the Forum.

Global financial crisis

TISL was among the first to highlight the need to understand the impact of the global financial crisis on Sri Lanka.
'Governance Dimensions of the Global Financial Crisis' was the theme of a round table discussion held to mark UN Anti-Corruption Day. Dr Sarath Amunugama, Minister of Enterprise & Investment Promotion was guest of honour.

Among the key speakers was Founder of Transparency International- Dr Peter Eigen, who was the chief guest. US Ambassador in Sri Lanka-Robert Blake, Chairman of Finlay PLC- Kumar Jayasuriya, Asian Development Bank Country Director-Dr Richard Vokes and LIRNE Asia Director-Dr Harsha de Silva were the other speakers'.

A lively discussion followed and the participants were appreciative of the opportunity provided by TISL to discuss a crucial issue of the day.

Spreading the message

Website

TISL website www.tisrilanka.org was constantly updated with news and features on corruption both at the local and global level. A weekly news feature titled 'Focus on Corruption' summarises news items and features in newspapers relating to corruption. TISL activities are recorded on a regular basis thereby keeping the viewers abreast of what is going on at TISL.

Newsletter

'Integrity' – TISL's Newsletter appears as a quarterly in English, Sinhala and Tamil to create awareness of TISL activities and to expose corrupt practices following extensive independent research on issues concerning public welfare. The tale of a neglected swimming pool in Badulla town wasting public money and a big racket around Employees Provident Fund (EPF) payments of illiterate estate workers were exposed thereby drawing the attention of the authorities on the need to take action.

Publications

Sri Lanka Governance Report 2008, released for the second successive year, discusses vital areas and key issues relating to the status of governance in Sri Lanka during 2007-08. With the rise in cost of living and an increased emphasis on national security, the year was fraught with governance related issues and many allegations of corruption and mismanagement.

The Report seeks to highlight the issues raised by the public and records both the successes and failures and in some instances comment on possible alterative measures that could have been taken. Main areas of integrity or the lack of it are addressed in the Report which is a vital document to those who research, study, advocate and work in the field of governance.





Cartoon competition

The anti-corruption cartoon competition created a lot of excitement and interest. It was organized with the aim of encouraging the public to propagate anti-corruption messages through the medium of cartoons and to create public interest and dialogue on corruption related issues in society at large. The response from all age groups was most encouraging. In all, 1003 entries were received, of which 437 were from those below 18 years of age and 566 from the adult category.

The entries represented all geographical districts in Sri Lanka except one (Mullaitivu). In spite of the war situation, a high number of entries were received from Jaffna, Batticaloa, Ampara and Trincomalee districts.

Ten prizes were awarded each of the two categories – youth and adult. The presentation of awards took place at a ceremony at the BMICH on 8 December – the UN Anti-Corruption Day. An exhibition of cartoons was also arranged at the venue.

Selected entries were used in a 12-month calendar which was distributed island-wide in collaboration with the Ministry of Public Administration through 'grama niladharis' thus reaching a wide clientele. In all, 20,000 calendars were printed.

National Integrity Award 2008

Continuing its commitment to recognize the courage and determination of individuals fighting corruption, TISL held the presentation of the National Integrity Award for the fifth successive year on 9 December 2008 – UN Anti-Corruption Day. Dr Peter Eigen, Founder of Transparency International was the chief guest.

Investigative journalist Thusitha Pitigala, producer of 'Vimarshana' – a daily programme broadcast over SirasaTV highlighting large scale corruption, and government school teacher and trade union activist S Priyantha Fernando from Raja Rata were the winners while Officer-in-Charge, Potuhera police station, Inspector Deshabandu Senaratne won a Special Mention.

The response for the Award is increasing every year with more and more inquiries flowing in. 73 nominations were received in 2008 from individuals and organizations. An independent panel of judges selected the winners.

An audience of 625 persons with diverse backgrounds representing the Public and Corporate Sectors, Community Based Organisations, NGOs, Trade Unions, Clergy and Media were present at the awards presentation.

Training journalists

Media has an indispensable role to play in preventing corruption. By exposing malpractices and investigating abuse of power, the media provides vital information to the public. In 2008 more and more journalists - both at national and regional levels - were exposed to tools of investigative journalism through TISL workshops.

Forty one national level journalists were trained at two workshops held in collaboration with the Sri Lanka Institute of Journalism and the School of Journalism. Among the subjects discussed were fundamentals of corruption, Sri Lankan status in Corruption Perception Index, methodologies to fight corruption, role of investigative journalism in curbing corruption and journalism ethics.

Ms Annie Zaidi, editor of the Indian magazine 'Tehelka' was the chief trainer at the second workshop. Among the topics discussed were current trends and problems in the field of development journalism, elements of bribery and corruption, nature and sources of motivation for development, peoples' movements and keeping out prejudices and stereotypes in the field.

Twenty seven regional journalists in the Badulla district attended a two-day workshop on investigative journalism held in association with the Regional Journalists Association in Badulla District. It was conducted by Poddala Jayantha, Secretary – Sri Lanka Working Journalists' Association. The participants responded that they gained skills and knowledge to report effectively on good governance and anti-corruption issues. Requests for more workshops were an indication of the success of the workshop.





Studies on vital issues

Education

A team led by Professor Amarasiri de Silva of the University of Peradeniya was commissioned to undertake a study on corruption in the state school system in Sri Lanka. The study was conducted from June – September 2008 using a mixed method of qualitative and quantitative data. Randomly selected 1,000 households, 100 teachers and 100 education officials were interviewed covering six districts – Anuradhapura, Galle, Kandy, Nuwara Eliya, Badulla and Puttalam.

The deterioration of the education system due to politicization, decline of the teaching profession, lack of teacher motivation, corruption in levying fees, acceptance of gifts were among the findings. The final report on the study is to be released in 2009.

Foreign employment

Corruption in recruitment for foreign employment is a key concern to a large number of females seeking employment. In that context, the Sri Lanka Bureau for Foreign Employment (SLBFE) commended TISL's decision to undertake a study on the integrity of such recruitment. The Centre for Women's Research (CENWOR) was commissioned to do the study. The report will be released in 2009.

Integrity in Local Government

'A study on integrity in local authorities was conducted with the objective of understanding the existing forms of corruption and malpractices in the local authorities and to identify the attitudes of their officials and elected members towards corruption. The study was carried out from 30July to 25 August 2008 in 20 Local authorities representing the districts of Budulla, Monaragala, Kurunegala and Puttalam. The problems highlighted in the survey included unduly delaying the work requesting bribes, inefficiency, negative attitude of the officials & lack of interest in their work, absence of officials during work hours, absences of procedures to hold officials accountable, and political patronage.

Ministerial expenditure

'Tracking Ministerial Expenditure: A quest for the Golden Fleece?' was the title of a research paper released in May 2008. The findings revealed that maintaining a huge body of 107 members comprising 50 Ministers, Non-Cabinet ministers and deputy ministers is unnecessary conserving the numerous overlaps. There are many instances of having two ministers for the same subject.

The research paper created public awareness of the vast burden thrust on the tax-payer in maintaining one of the biggest Cabinets in the world.





Institutional Development

Having identified Institutional Development as a key strategic focus area to enhance the vibrancy of TISL to implement its activities, several initiatives were put in place during 2008.

Progress Reporting

Monthly progress is maintained by each programme area to be fed into the quarterly progress reports and eventually into the annual progress report.

Annual Planning Workshop

The Work Plan and Budget 2009/10 was developed through a participatory process involving all staff of TISL.

Performance Evaluation

A staff performance evaluation was conducted in November 2008 enabling the organization to obtain feedback about the effectiveness of its organization structure and staff performance.

Staff Expansion

TISL staff expanded and the numbers stood at 23 by end October 2008. Most of the recruits are university graduates. In order to maintain smooth functioning and to ensure better utilization of the skills of the staff, the position of Human Resource Manager was created. This will further streamline the recruitment process. A comprehensive HR policy will be developed.

Regular Meetings

Seven Board meetings and regular management meetings were held during the year. The monthly staff meetings provide an opportunity to discuss relevant issues and exchange views.

Staff Training

Several staff training programmes were conducted both inhouse and external in order to help in career development.

As part of staff development, an outbound training programme was arranged. The two-day programme held at Belihul Oya in April 2009 was intended to create a more collective team effect among the staff. It helped to strengthen team spirit and the capacity to respond to challenging situations.

Staff Welfare

The Health Insurance Scheme entitles all permanent employees, their spouses and off-spring to medical insurance, whilst the TISL Personal Accident Cover provides coverage for all staff for permanent total and partial disabilities, temporary disablements, riots and strikes and terrorism.





At Global Level

TISL is part of Transparency International (TI), the global network fighting against corruption. Issues relating to corruption and governance issues are discussed at the Annual Membership Meeting and at meetings held at regional level.

TISL participated at the Asia Pacific (TIAP) Regional Conference held in Manila, Philippines in May 2008 where issues relating to challenges and how to overcome them were discussed. Successful programmes within the region were presented and possible collaborative efforts to counter corruption within the region were discussed. Fund raising was another subject that came up for discussion.

Representing TISL at the Manila Conference were Deputy Executive Director Rukshana Nanayakkara and Finance Manager Dilshan Weerasinghe.

The Annual Membership Meeting and International Convention against Corruption held in Athens, Greece in October 2008 was attended by Executive Director J C Weliamuna, Deputy Executive Director Rukshana Nanayakkara, Programme Director T Kalaimagal and Senior Advisor Bettina Meier.

Members' Day

There was a good response for the first-ever TISL Members' Day held at the Galadari Hotel, Colombo on 20 June 2008. There was consensus among members that TISL has been well accepted and people are appreciative of its efforts to eliminate corruption and promote integrity.

At the annual general meeting that followed, the members were briefed on the work done during the year.

Internship Programme

TISL's internship programme is well appreciated. Interns from local and foreign universities and other educational institutions interned at TISL throughout the year. They served for periods between three weeks to three months. 

Board of Directors



M.D.A. Harold - Chairman

Has been serving as Chairman of TISL since December 2004. He is a former Deputy Auditor General with 26 years experience in the Auditor General's Department and a total of 40 years of experience in the Sri Lanka State Services beginning in 1963. He is a Fellow of the Institute of Public Financial and Development Accountancy and a senior member of the Association of the Accounting Technicians of Sri Lanka. He lectures at the Sri Lanka Institute of Development Administration, the Institute of Government Accountancy and Finance, and the Institute of Supply and Material Management. He holds Diplomas in Accountancy from Ceylon Technical College, and Public Financial Management from the Sri Lanka Institute of Development Administration (SLIDA).

Dr. P. Saravanamuttu

The most senior director at TISL, he was involved in its establishment as the National Chapter of the global movement, Transparency International. He obtained his PhD (1986) and Bachelor's (1979) in International Relations from the London School of Economics and Political Science (LSE), University of London. He is currently the Executive Director of Centre for Policy Alternatives. He also lectures at the University of Colombo and the Bandaranaike Centre for International Studies. A regular contributor to the media, he is quoted widely on Sri Lankan issues both in local and international print and electronic media. Dr. Saravanamuttu has contributed to a variety of international conferences organised by academic and policy oriented institutions on subjects ranging from governance and policy reform to ethnicity, international politics and conflict resolution.

Tassie Seneviratne

A retired Senior Superintendant of Police with 37 years of experience as a Law Enforcement Officer. He was the Convenor SASA NET from 2002 to 2003 in the Campaign against Proliferation of Small Arms in South Asia (South Asia Partnership). He was also Director of Investigations in the Programme for the Protection of Public Resources implemented by Institute of Human Rights & TISL

Nelum Gamage

An Attorney at Law currently serving as a consultant to the Legal Aid Commission of Sri Lanka. She had served the government of Sri Lanka for over 30 years prior to retiring as the Additional Secretary, Ministry of Justice and Legal Reforms. Her service in the Bribery Commissioner's Department since 1975 culminated with her becoming the first female Bribery Commissioner, a position she held from 1989 to 1994. She also served as the Director General of the Commission to Investigate Allegations of Bribery and Corruption from 1994 to 1997.

Chandra Jayaratne

A Fellow of the Institute of Chartered Accountants of Sri Lanka and the Chartered Institute of Management Accountants. Having extensive cross-functional corporate sector experience since 1965, he has been the Managing Director of Eagle Insurance Company Limited since 1994. He is a former Chairman of the Ceylon Chamber of Commerce. He is a consultant to the World Bank on **Regional Planning and Regional Economic Development** and to the Asia Pacific Philanthropy Consortium on Civil society. He is a professional Facilitator at the Finance and Banking Commission and a member of the Financial Sector Reforms Committee at the Central Bank of Sri Lanka. He was awarded the Eisenhower Exchange Fellowship USA in 1989 for Mid Career Professional Development. He was 'Sri Lankan of the Year 2001' by LMD Magazine in recognition of being the Voice of Business Promoting 'Vision 2020'.

V. K. Nanayakkara

Former Secretary to the Prime Minister and Secretary to the Ministry of Education, he is presently the Director of the Hector Kobbekaduwa Agrarian Research Institute. At the time of his retirement, he was a Class I officer of the Sri Lanka Administrative Service.

S.K. Liyanage

Winner of the National Integrity Award 2007 when he was recognized for his tireless efforts in fighting corruption. He holds a Bachelor of Arts degree from the Kelaniya University and a LLB from the Open University of Sri Lanka. A Class I Officer of the Sri Lanka Administrative Service, he retired as the Additional Secretary to the Ministry of Provincial Council and Local Government. After retirement, he served as Additional Government Printer in Sri Lanka Printing Department (Government Press). He is well reputed as an investigator in the public service in Sri Lanka.

Anushya Coomaraswamy

A fellow of the Institute of Chartered Accountants of Sri Lanka, the Chartered Institute of Management Accountants of the UK and the Society of Certified Managements Accountants of Sri Lanka. She has worked for more than 20 years in the private sector in senior management positions. After serving as Group Finance Director - John Keells Holdings Limited (1994-2002), she joined the Ministry of Finance in January 2003 as an adviser with particular involvement in fiscal policy and public debt. In addition to being a Non Executive Director on the Boards of two private companies, she is also a member of the Board of Directors of Centre for Policy Alternatives and Consortium of Humanitarian Agencies.



Looking Ahead



Following the mid-term evaluation of TISL's Strategic Plan 2007-2011, certain adjustments and reorientation of activities were decided upon. Thus it was decided to restructure TISL's activities to achieve greater synergies and to avoid duplication. This is also intended to have a greater impact on TISL's work.

Five new Units – Research, Advocacy, Capacity Building, Communication & Institutional Development were formed to be operative from January 2009.

Summary of Significant Accounting Policies

General Policies Statement of Compliance

The Financial Statements have been prepared in accordance with Sri Lanka Statement of Recommended Practice for Not – For – Profit Organisations (including NGOs), by the Institute of Chartered Accountants of Sri Lanka (ICASL).

Basis of Measurement

The Financial Statements have been prepared on the historical cost basis.

Grants

Grants received on account of specific projects have been credited to the appropriate restricted fund (project fund). These sums are then transferred to income account as and when the relevant expenses are being charged.

Monetary Grants and Donations received without any specific conditions are credited directly to income account to be used against normal unrestricted expenses of the Organisation.

Transactions in Foreign Currency

All other assets and liabilities denominated in foreign currencies at the year end are translated at the exchange rates prevailing at the balance sheet date.

Other normal foreign currency transactions are converted at the exchange rates prevalent on the date of the transaction.

All gains or losses on foreign currency transactions is transferred to Restricted Funds Account.

Property, Plant and Equipment Cost or Valuation

Property, Plant and Equipment are reflected at cost less accumulated depreciation. Property, Plant and Equipment purchased for projects would be capitalized at the completion of projects at their fair values determined by the Directors.

Depreciation

A full year's depreciation is charged in the year of sale and none in the year of purchase. Fixed assets are depreciated at 25% per annum on a straight line basis.

Summary of Significant Accounting Policies - Continued

Investments - Treasury Bills

Treasury Bills are accounted for at cost plus the relevant proportion of the discount. Investment income is credited to Restricted Fund Account.

Defined Benefit Plan - Gratuity

Full provision has been made in the accounts for retiring gratuities payable under the Payment of Gratuities Act No. 12 of 1983, for all employees, including those who have less than five years of continued service. Gratuities are recognized as project expense in the period during which their services are rendered, in accordance with Sri Lanka Accounting Standards 16 – Retiring Benefits Costs.

Defined Contribution Plans - Employees' Provident Fund and Employees' Trust Fund

Employees are eligible for Employees Provident Fund contributions and Employees Trust Fund Contributions in line with the respective Statutes and Regulations. The Company contributes 12% and 3% of the salary of each employee to the Employees' Provident Fund and the Employees' Trust Fund respectively.
